Community Resource Paramedic Program Update:

CRP-Dean Speerbrecher briefed on the status of the Community Resource Paramedic Program

- Vaccines are going to be part of a focus again.
- Upcoming extensive need for mental health; will be collaborating with other agencies
 - o In the past, in Island County, Richard West, was an embedded Social Worker and was collaborated with to support the needs of the community and help gain them resources.
 - o Seeking to collaborate more with mental health professionals
 - With restrictions on law enforcement dealing with mental health there's going to be a greater need for support from the Fire Department to aid with mental health.
- Narcotic outreach
- Collaboration with adult protective services

- Grant proposals- with the award of a recent grant, CIFR plans to put on a cadaver lab. We've requested two bodies and a torso from a Portland Company. Cadaver labs offer some of the most relevant and best training. We'll invite other agencies to attend. Want to bring in about 40 people. So many medics report that the cadaver lab is invaluable.
- Chief Yengoyan indicated that Dean has been instrumental in vaccine clinic. Thank you extended to Dean for his role.
- Question—what is Dean's role for tracking or assisting with mental health? The community paramedic can liaison with healthcare providers to add additional resources. Also, building rapport with patients then being present when they need care is invaluable.
- A discussion occurred surrounding the rapport between patients who need mental health assistance.
- Request to see gaps in the resources at the CRPs disposal.
- Grant writer may be a resource that would be of a great benefit.
- Discussion surrounding PTs who are no longer able to care for themselves and connecting them with resources.
