## **CHIEF'S REPORT** – None

Strategic Planning Update—Steve Knight, Fitch & Associates

Steve Knight provided a brief overview of his and the company's background; the process for gathering data and information; and the partnership required to build standards of cover and strategic planning.

Requested input on what the Commissioners would like to see.

Comm Treml requested more details regarding the process.

-Standards of Cover is a risk-based assessment. They will apply risk matrixes down to the station level and match resource allocation to level of risk. Like-risk gets like-mitigation response. Population aging has a significant impact on numbers of calls. Socioeconomic and demographic values will be used in the building the story and risk factor. One of the tenants of strategic planning is getting community feedback to provide a targeted approach. They will try to focus efforts on outcomes and produce a higher-level view of what you are trying to accomplish.

Comm Evans inquired how we can get demographic analysis for North vs. South end of the island?

-We'll take census data and apply the demographics to those areas. We'll build a comparison table so those political sensitivities can be seen.

What's the next step from Fitch and how can the board get involved?

- They are in the process of mining all the data. Will use the data to build a GIS report and will come back out to meet with the department and can have a meeting either with the Chief or with the board to evaluate what happens from there. That's when some of the other scope elements will come into play.
