Administrative Updates

Contract Negotiations

We've made solid progress addressing concerns raised during our recent audit of shift trade practices. We're currently working with the union on a financial proposal. Key areas of focus include:

- Sick leave buyout structure upon separation
- Post-retirement medical benefits
- Wage adjustments

We'll be able to assess the full financial impact once we receive their proposal. Discussions so far have been respectful and solution-oriented.

Assistant Chief Fields

Chief Fields officially started this week and is off to a great start. He spent two days onboarding, connecting with team members, and getting set up in his new office. He'll continue easing in over the next few weeks and begin full-time duties on August 4.

Station 1-5 Remodel

Our permit application is under review by Island County. We're simultaneously collecting contractor quotes. While we had hoped to present bids today, we'll need a short board meeting on July 23 to review and approve contractor selection. This parallel track should help us stay on schedule.

EMS Levy Outreach

Public engagement is going well. I've shared levy details with: Windermere Realtors, Madrona Water Association, Community Preparedness Group

ACH Funding Update

We haven't received updated ACH funding news yet. However, we've met with representatives from Senator Murray and Representative Larsen's offices about our HRSA grant. They're providing a letter of support and have invited us to apply for FY2026 earmark appropriations next February.

Brush Truck Bid

I have included the Brush Truck Bid in this month's action items. When we approached the company about the bid to approve the purchase, they advised that their recommendation was to lower the tank size and lengthen



it to reduce the center of gravity. This was added to the initial bid. However, the Company is Canadian, and we overlooked that the bid did not include tax. Their sales team has indicated that they are tariff exempt, but they are unable to confidently quote import duty and tax. The bid for \$29,749.37 is in US funds. I'm seeking approval for no more than \$40,000 to ensure we have ample room for tariffs, taxes, or importer fees, which is still well within the amount we earned in California on the rig deployment.

Personnel Updates

New Hire: Tony Bacerra

Tony joined us last week from Whidbey Health EMS. He's currently completing orientation and will start his preceptorship on A shift, with academy in September. Until then, he won't count toward minimum staffing due to training status, despite our and the union's efforts to accommodate this for August staffing.

Leave Status

We have two personnel out:

- Maternity Leave expected return September
- L&I Leave also expected to return September

Recruitment & Staffing

We're conducting second interviews next week to finalize a standing list for future Firefighter and FF/Paramedic openings. We're at our current staffing goal of 34 full-time FFs. If the EMS levy passes, we may reassign the MSO position to day shift, increasing to 35 full-time FFs.
